Official Rules – Huntington Remodel Sweepstakes – Huntington Member Center

ELIGIBILITY: To enter the Sweepstakes, you must be a lawful resident of the United States, 18 years of age or older and must not be considered a minor in your state of residence. The Sweepstakes is void outside of the United States and where restricted or prohibited by law. Beacon Credit Union (Beacon) employees, board of directors, committee members, and members of their immediate families and households are not eligible to participate.

HOW TO ENTER: NO PURCHASE NECESSARY TO ENTER. The Sweepstakes begins and ends on September 22, 2026 from 4pm to 6pm (“Entry Period”). There are two ways to enter: (1) by submitting an entry form at the Huntington Member Center, 136 Northpoint Ave, Huntington, IN, 46750. (2) by sending in a 3x5 postcard to Beacon Credit Union – ATTN: Huntington Remodel Sweepstakes, PO Box 627, Wabash, IN, 46992, requesting to be entered into the Sweepstakes. The postcard must contain the name, address, and phone number of the person requesting to participate in the Sweepstakes. Such entries must be **received by September 29, 2026**. Proof of mailing does not constitute proof of delivery. Once submitted, entries become the sole property of Beacon and will not be acknowledged or returned. No copies or mechanical reproductions of entry forms will be accepted. By submitting an entry, by participating in this promotion, or by accepting any prize you agree to be bound by these Official Rules.

DRAWING: A random drawing will be held for the qualifying entries received during the Entry Period (see below). The winner will be selected from all eligible entries received during the Entry Period described below, by Beacon. Odds of winning a prize depends on the number of entries received. The winner will be notified by phone. If the winner cannot be reached within five (5) business days from the first notification attempt, then such person shall be disqualified and an alternate winner will be selected.

Entries will not be accepted at the Administration Building at 586 S. Wabash Street in Wabash or any other Member Center.

PRIZE CONDITIONS: In the event a Beacon representative determines, in its sole discretion based on his/her interpretation of these Official Rules, that an entrant is found to be ineligible, or if he/she does not comply with these Official Rules, then the potential winner will be disqualified and an alternate winner will be selected through a random drawing from the remaining entries. If the prize winner is not able to be reached by phone, this will result in disqualification and an alternate winner will be selected. To claim a prize, the winner must sign and return a Prize Acceptance and Release and an Affidavit of Eligibility and Publicity Release to Beacon at PO Box 627, Wabash, IN 46992 within 14 days of notification; or prize will, at Beacon’s discretion, be forfeited. Prize will be awarded only if entrants comply with these Official Rules. No cash or other consideration will be paid and winners are responsible for any applicable expenses related to any prize awarded.
