Official Promotion Rules - Member Appreciation Day Giveaway

ELIGIBILITY: To enter the Giveaway, you must be a lawful resident of the United States, 18 years of age or older and must not be considered a minor in your state of residence. The Giveaway is void outside of the United States and where restricted or prohibited by law. Beacon Credit Union (Beacon) employees, board of directors, committee members, and members of their immediate families and households are not eligible to participate in the Giveaway.

HOW TO ENTER: The Giveaway begins and ends on the following for individual Member Center Member Appreciation Days:

Wabash Miami St., Wabash Wedcor, and North Manchester: June 13, 2025 - 8:30 am to 5:00 pm

New Haven, Auburn Grandstaff, Auburn 7th Street and Garrett: June 27, 2025 - 8:30 am to 5:00 pm

Seymour – August 29, 2025 - 8:30 am to 5:00 pm

Marion, Huntington – July 18, 2025 - 8:30 am to 5:00 pm

Rushville – August 8, 2025 - 8:30 am to 5:00 pm

Rochester Main St, Rochester Rouch Place Dr., Plymouth, and Warsaw – September 12, 2025 - 8:30 am to 5:00 pm

Peru N. Broadway, Peru W. Main, Logansport Mall Rd, and Logansport W. Market – September 19, 2025 - 8:30 am to 5:00 pm

There is one way to enter: (1) Enter on site via the form on the day of drawing. Once submitted, entries become the sole property of Beacon and will not be acknowledged or returned. Only one entry per person, per location. By submitting an entry, by participating in this promotion, or by accepting any prize you agree to be bound by these Official Rules.

DRAWING: A random drawing will be held for the qualifying entries during the Entry Period listed above. The winners will be selected from all eligible entries received during the entry periods described above, by Beacon Credit Union. Odds of winning a prize depends on the number of entries received. The winners will be notified by phone. If the winners cannot be reached within thirty (30) days from the first notification attempt, then such person shall be disqualified and an alternate winner will be selected. A person may only be chosen as a winner in one location during the Member Appreciation Day Giveaways.

PRIZES: Beacon will award a total of three (3) prizes consisting of the following: One (1) winner will be awarded \$250 cash. One (1) winner will be awarded \$150 cash. One (1) winner will be awarded \$100 cash. There will be three prize winners at each Member Center Location.

PRIZE CONDITIONS: In the event a Beacon representative determines, in its sole discretion based on his/her interpretation of these Official Rules, that an entrant is found to be ineligible, or if he/she does not comply with these Official Rules, then the potential winner will be disqualified and an alternate winner will be selected through a random drawing from the remaining entries. If the prize or prize notification is returned as undeliverable, this will result in disqualification, and an alternate winner will be selected. To claim a prize, the winner must sign and return a Prize Acceptance and Release and an Affidavit of Eligibility and Publicity Release to the Credit Union at PO Box 627, Wabash, IN 46992 within 14 days of notification; or prizes will, in the Credit Union's discretion, be forfeited.
